- Develop and maintain strong Financial/Strategy & Growth Communications process management tools
- Manage ongoing research to develop a deep understanding of key audiences and stakeholders, including media and business development partners/prospective partners, to expertly reach target audiences and instill confidence in the company. Continuously track and analyze perceptions of Novartis by the Business Development community to understand their drivers and mitigate potential issues
